NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and delivery of 253 sets MV Power Cable Splicing Kits for various Airports in the total amount of SIX HUNDRED SEVENTY-SEVEN THOUSAND SEVEN HUNDRED TWENTY-THREE & 75/100 PESOS (P677,723.75) only, and be AWARDED to Gloval Integrated Solutions and Technological Services Inc., the offer of which was considered reasonable and advantageous to the Government;
