## CCC Resolution No. 2024-025

SUBJECT:

SUPPLY AND DELIVERY OF G5 MEDICAL GRADE LITHIUM ION BATTERY.

WHEREAS, Purchase Request/POW/CBA No. 24-03-332 dated 06 March 2024 for the Supply and Delivery of G5 Medical Grade Lithium Ion Battery with a total budget of P68,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as Annex A;

WHEREAS, on 27 March 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, the Request for Quotation (RFQ) was twice posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 13 April 2024 and 26 April 2024, no quotation was received by the CCC Secretariat. The project was re-posted on 10 May 2024, Copy of PhilGeps postings hereto attached as Annex C;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and Delivery of G5 Medical Grade Lithium Ion Battery in the total amount of SIXTY-EIGHT THOUSAND PESOS (P68,000.00) only, and be AWARDED to Beemax Consumer Goods Trading, the offer of which was considered reasonable and advantageous to the Government;
