



CCC Resolution No. 2024-024

SUBJECT: SUPPLY AND DELIVERY OF MEDICAL DENTAL SUPPLIES.

WHEREAS, Purchase Request/POW/CBA No. 24-02-0232 dated 16 February 2024 for the Supply and Delivery of Medical Dental Supplies with a total budget of P532,182.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as Annex A;

WHEREAS, on 03 May 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, *"Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR"*. WHEREAS, BAC Resolution No. 2024-0212-28 dated 15 March 2024 was signed for the change of mode of procurement. Copy of the Resolution hereto attached as Annex C;

WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 10 May 2024, Copy of PhilGeps postings hereto attached as Annex D;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

1. BEEMAX CONSUMER GOODS TRADING;
2. AYAMED DRUG DISTRIBUTOR;
3. RPD CHEM ENTERPRISES;
4. WISENHEIMER TRADING;
5. MERRITMED MEDICAL SUPPLIES; and
6. FREDOWIL MEDICAL SUPPLIES;

WHEREAS, during the opening of the sealed RFQs held on 17 May 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

1. BEEMAX CONSUMER GOODS TRADING	P523,055.00

WHEREAS, the end-user evaluation report submitted on 22 May 2024 disclosed that Beemax Consumer Goods Trading complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as Annex E;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "*Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation.*"

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and Delivery of Medical Dental Supplies in the total amount of FIVE HUNDRED TWENTY-THREE THOUSAND FIFTY-FIVE PESOS (P523,055.00) only, and be AWARDED to Beemax Consumer Goods Trading, the offer of which was considered reasonable and advantageous to the Government;
