CCC Resolution No. 2024-037

SUBJECT: SUPPLY AND DELIVERY OF POWER SUPPLY UNIT (PSU) FOR TAGAYTAY RADAR BEEL TRANSPONDER AT MANILA AFC.

WHEREAS, Purchase Request/POW/CBA No. 24-04-503 dated 22 April 2024 for the Supply and Delivery of Power Supply Unit (PSU) for Tagaytay Radar Beel Transponder at Manila AFC with a total budget of P78,400.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 24 May 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, *"Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR"*. WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 04 June 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

1. D.T.S. ELECTRONICS AND TELECOMMUNICATION PARTS AND EQUIPMENT RETAILING;
2. LSI LEADING TECHNOLOGIES;
3. AGILE TECHFRONTIER CORP.;
4. BEEMAX CONSUMER GOODS TRADING;
5. TABUKO POWER RESOURCES CORPORATION;
6. PANTRONICS INTERNATIONAL CORPORATION;
7. METOS OFFSHORE INC.; and
8. WINGS TECHNOLOGY ENTERPRISE, INC;

WHEREAS, during the opening of the sealed RFQs held on 07 June 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

WHEREAS, the end-user evaluation report submitted on 13 June 2024 disclosed that Wings Technology Enterprise, Inc. complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex D**;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, *"Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."*

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby RESOLVED to recommend for **APPROVAL** of the Supply and Delivery of Power Supply Unit (PSU) for Tagaytay Radar Beel Transponder at Manila AFC in the total amount of **SEVENTY-EIGHT THOUSAND FOUR HUNDRED PESOS (P78,400.00)** only, and be **AWARDED** to **Wings Technology Enterprise, Inc.** the offer of which was considered reasonable and advantageous to the Government;
