WHEREAS, the Request for Quotation (RFQ) was first posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 27 April 2024, only one (1) quotation was received by the CCC Secretariat but it was disqualified due to non compliance in the documentary requirements.
