**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND
RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES AT
EVELIO B. JAVIER (ANTIQUE) AIRPORT**

WHEREAS, BAC Resolution No. AREA6-EBJ-SVP-2024-002-01 for the project **Supply and Delivery of Janitorial Supplies at Evelio B. Javier (Antique) Airport** with Approved Budget for the Contract (ABC) in the amount of **Seventy Seven Thousand Seven Hundred Seven Pesos (₱ 77,707.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Five (5) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Five (5) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last September 11, 2024, **JV SCHOOL SUPPLIES** was declared Lowest Submitted Quotation with the Bid amount of **Sixty One Thousand Six Hundred Forty Four Pesos & 75/100 (₱ 61,644.75)**;

WHEREAS, bid submitted by the following bidders:

- a) **VGM SCHOOL AND OFFICE SUPPLIES TRADING** has been disqualified during the bid opening due to Non-submission of eligibility requirements as stated in the Request for Quotation:
 1. **Omnibus Sworn Statement and**
 2. **Special Power of Attorney**

In Section 30.1. of the 2016 revised IRR of RA No.9184 "The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed."

- b) **GELO'S SCHOOL AND OFFICE SUPPLIES** has been disqualified during the bid opening due to Non-compliance of the Request for Quotation Terms and Condition Item No. 1: "*Bidders must provide **correct** and **accurate** information required in this form.*" and,



- c) **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** has been disqualified during the bid opening due to:
- a) Non-compliance of the Request for Quotation Terms and Condition Item No. 1: "Bidders must provide **correct and accurate** information required in this form." and,
 - b) Absence of notarization date of Secretary Certificate.

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:



- a) To declare, **JV SCHOOL SUPPLIES** as the Supplier with the **Lowest Calculated Responsive Quotation** for the project **Supply and Delivery of Janitorial Supplies at Evello B. Javier (Antique) Airport** in the bid amount of **Sixty One Thousand Six Hundred Forty Four Pesos & 75/100 (₱ 61,644.75)**;
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
