**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID AND
 RECOMMENDING APPROVAL FOR THE REPAIR AND MAINTENANCE OF 3 UNITS PBB
 AT ILOILO INTERNATIONAL AIRPORT**

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for the **Repair and Maintenance of 3 Units PBB at Iloilo International Airport** in the PhilGEPS and in conspicuous places at the premises of the Civil Aviation Authority of the Philippines with the ABC of **One Million Seven Hundred Fifty-Two Thousand Four Hundred Seventy-Seven Pesos & 33/100 (₱ 1,752,477.33)**;

WHEREAS, in response to the said advertisement, one (1) interested bidder submitted its letter of intent and bought the bidding documents;

WHEREAS, on the day of the Preliminary Examination of Bids, one (1) bidder submitted its sealed bid proposal;

WHEREAS, during the Bid Opening last June 20, 2024, **ALJON INTERNATIONAL CORPORATION** was declared as the Single Calculated Bid with the Bid amount of **One Million Seven Hundred Fifty-Two Thousand Two Hundred Forty Pesos (₱ 1,752,240.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially complying:
