RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF 68 UNITS CUSHIONED GANG CHAIRS FOR SPECIAL CATEGORY PASSENGER AT ILOILO INTERNATIONAL AIRPORT (AREA CENTER 6)

WHEREAS, BAC Resolution No. BSVP-ILO 2024-042-02 for the project **Supply and Delivery of 68 Units Cushioned Gang Chairs for Special Category Passenger at Iloilo International Airport (Area Center 6)** with Approved Budget for the Contract (ABC) in the amount of **Seven Hundred Eighty Nine Thousand Nine Hundred Twenty Pesos (P 789,920.00)** hereby form the integral part of this resolution. WHEREAS, during the Bid Opening last August 16, 2024, **SOLIDGOLD MULTI RESOURCES CORPORATION** was declared Lowest Submitted Quotation with the Bid amount of **Six Hundred Twenty Nine Thousand Pesos (P 629,000.00)**;


