



BAC Resolution No. 2024-0212-88 (Alpha)

SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PROCUREMENT OF CONSTRUCTION OF CHB FENCE AT CATARMAN AIRPORT (Bid No. 24-021-04 Alpha)

WHEREAS, the project, Procurement of Construction of CHB Fence at Catarman Airport, an ADMS project was forwarded to the Bids and Awards Committee – Alpha of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Four Million Nine Hundred Ninety-Four Thousand, Eight Hundred Fifty-Nine Pesos & 07/100 (Php4,994,859.07). A copy of the Certificate of Budget Allocation CBA (C.O) No. 24-03-355 dated 15 March 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 18 April 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 25 April 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 09 May 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "D"*;

WHEREAS, the Submission and opening of bids for the project was held on 23 May 2024 at the CAAP Conference Room and via video conference. Bidders submitted their bid proposals for the project, and the following results were noted. A copy of the Minutes of the Meeting and Abstract of Bids as Read are hereto attached as *Annexes "E" & "F"*, respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group (BAC-TWG) issued its Bid Evaluation Report dated 28 May 2024 and was presented to the BAC on the same day, where it is indicated that the bid proposals of F2K Engineering and Construction and 5GG Construction be disqualified for tendering an incomplete bid for offering a deficient list of materials, labor and equipment in the required items in the bill of Quantities and Detailed Estimates, and for Quin Sterling Construction, Inc. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB). WHEREAS, the Committee issued a letter to Quin Sterling Construction, Inc dated 29 May 2024 requiring the same to submit the necessary additional requirements for post-qualification. A copy of the said letter is hereto attached as *Annex "I"*;

WHEREAS, the BAC TWG (Alpha) issued its Post-Qualification Report dated 13 June 2024 and was presented to the BAC on 18 June 2024, wherein the BAC TWG (Alpha) recommended that the bid proposal of **Quin Sterling Construction, Inc.** be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of **FOUR MILLION FOUR HUNDRED FIVE THOUSAND, TWO HUNDRED NINE PESOS & 50/100 (PHP4,405,209.50)**. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K"*, respectively;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;*

NOW, THEREFORE, premises considered, the **CAAP-BAC (ALPHA) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, Procurement of Construction of CHB Fence at Catarman Airport in the total amount of Four Million Four Hundred Five Thousand, Two Hundred Nine & 50/100 **(Php4,405,209.50) to Quin Sterling Construction, Inc.**
