

CCC Resolution No. 2024-048

SUBJECT: GENERAL PEST CONTROL ON SELECTED BUILDINGS AT CAAP CENTRAL OFFICE.

WHEREAS, Purchase Request/POW/CBA No. 24-04-546 dated 30 April 2024 for the General Pest Control on selected buildings at CAAP Central Office with a total budget of P429,082.56 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 17 July 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, BAC Resolution No. 2024-0212-68 dated 27 May 2024 was signed for the change of mode of procurement. Copy of the Resolution hereto attached as **Annex C**;

WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 23 July 2024, Copy of PhilGeps postings hereto attached as **Annex D**;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

WHEREAS, during the opening of the sealed RFQs held on 26 July 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

WHEREAS, the end-user evaluation report submitted on 30 July 2024 disclosed that POWER HOUSE PEST CONTROL SERVICES complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex E**;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby RESOLVED to recommend for **APPROVAL** of the General Pest Control on selected buildings at CAAP Central Office in the total amount of **TWO HUNDRED THIRTEEN THOUSAND TWO HUNDRED FORTY PESOS (213,240.00) only, and be AWARDED** to **POWER HOUSE PEST CONTROL SERVICES**, the offer of which was considered reasonable and advantageous to the Government;
