



*BAC Resolution No. 2024-0212-111 (Alpha)*

**SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, IMPROVEMENT/REHABILITATION OF PASSENGER TERMINAL BUILDING AT ITBAYAT AIRPORT (Bid No. 24-042-06 Alpha)**

**WHEREAS**, the project, Improvement/Rehabilitation of Passenger Terminal Building at Itbayat Airport, an ADMS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Seven Million Four Hundred Eighty-Nine Thousand Three Hundred Seventy-Six Pesos & 51/100 (PHP7,489,376.51). A copy of the Certificate of Budget Allocation (CBA (C.O) 24-05-633 dated 18 May 2024) is herein attached as *Annex "A"*;

**WHEREAS**, Pre-procurement Conference was conducted on 18 June 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS**, the Invitation to Bid (ITB) was posted on 28 June 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, Pre-bid Conference was conducted on 09 July 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, during the Opening of Bids on 23 July 2024, there was no bid offer received by the BAC Secretariat, thus the BAC-TWG recommended for the failure of bidding for this project. A copy of the Minutes of Meeting is hereto attached as *Annex "E"*;

**WHEREAS**, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: "The BAC shall declare the bidding a failure when no bids are received";

**NOW THEREFORE**, premises considered, the **CAAP-BAC (Alpha)**, hereby **RESOLVES** to declare the project, Improvement/Rehabilitation of Passenger Terminal Building at Itbayat Airport a **FAILURE** and to return the documents to the end-user for mandatory review.
