*BAC Bravo Resolution No. 2024-0212-79 (Bravo)*

**SUBJECT: RECOMMENDING THE CANCELLATION OF BIDDING FOR THE PROJECT ENTITLED PROCUREMENT OF CAAP CENTRAL OFFICE SERVICE VEHICLE (4 VEHICLES).**

**WHEREAS**, the project M **PROCUREMENT OF CAAP CENTRAL OFFICE SERVICE VEHICLE (4 VEHICLES)**, a Motorpool-AFS project, was forwarded to the CAAP Bids and Awards Committee - Bravo (CAAP-BAC-Bravo) for its procurement. The project has an approved budget amounting to Eight Million Pesos (**Php 8,000,000.000**). A copy of the Certificate of Budget Allocation (CBA (MOOE) No. 24-02-195 dated 14 February 2024) is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement was on 01 April 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of the Meeting is hereto attached as *Annex "B"*;

**WHEREAS**, the Invitation to Bid (ITB) was posted on 13 May 2024 in the PhilGEPS, CAAP official Website and in other conspicuous places in the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 22 May 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of the Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, during the BAC-BRAVO meeting on 29 May 2024, the End-User recommended for the cancellation of the procurement of the project under Section 35.6 of the Revised Implementing Rules and Regulations of Republic Act 9184, considering there was adjustment in the proposed Certificate of Budget Allocation. A copy of the Minutes of the Meeting is hereto attached as *Annex "E"*;

***Section 35.6: Reservation Clause***

Without prejudice to Sec 35.1 hereof, the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to:

(c) the source of the funds for the project has been withheld or reduced through no fault of the Procuring Entity.



**NOW THEREFORE**, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of **BAC-TWG (Bravo)**, as it is hereby **RESOLVED** that the bidding for the project **PROCUREMENT OF CAAP CENTRAL OFFICE SERVICE VEHICLE (4 VEHICLES)** be cancelled and to revert the Bid Documents to the End-User for review;
