## SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PROCUREMENT OF WORKSTATIONS FOR AMHS AT PHIL. ATMC AND REMOTE SITES AND RCMS OF RADAR SITE (RE-BID)

**WHEREAS**, the project, Procurement of Workstation for AMHS at Phil. ATMC and Remote Sites and RCMS of Radar Site, an ANS project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Four Million Nine Hundred Ninety-Four Thousand Six Hundred Pesos (Php4,994,600.00). A copy of the Certificate of Budget Allocation (CBA (C.O) #24-02-257 dated 21 February 2024 is herein attached as *Annex "A"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 24 April 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "B*";

**WHEREAS**, the Pre-bid Conference was conducted on 03 May 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "C"*;

**WHEREAS,** Bid Bulletin No.1 dated 08 May 2024 was issued for some clarification/revision/amendments in the bidding documents of the project. A copy of the notice of the Bid Bulletin no.1 is hereto attached as *Annex "D"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 22 May 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Abstract of Bids as Read are hereto attached as *Annexes "E" & "F", respectively;*

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 29 May 2024 and was presented to the BAC on the same day, where it is indicated that the tendered bid proposal of iEquity Technologies, Corp. to undergo Post-Qualification process for being evaluated and considered as the Lowest Calculated Bid (LCB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. WHEREAS, the Committee issued a letter to IEquity Technologies Corp., dated 03 June 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "I";

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report dated 01 July 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of IEquity Technologies Corp. to be declared as the Lowest Calculated Responsive Bid (LCRB) in the amount of Four Million Nine Hundred Seventy-Seven Thousand Six Hundred Pesos (Php4,977,600.00) for the project Procurement of Workstations for AMHS at Philippine ATM Center and Remote Sites and RCMS of Radar Sites. The copy of said Report and Minutes of Meeting are hereto attached as Annexes "]" & "K", respectively.;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project IEquity Technologies Corp., in the amount of Four Million Nine Hundred Seventy-Seven Thousand Six Hundred Pesos (Php4,977,600.00).

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of BAC-TWG (Bravo), hereby RESOLVES to APPROVE and AWARD of the project, Procurement of Workstations for AMHS at Philippine ATM Center and Remote Sites and RCMS of Radar Sites in the amount of to Four Million Nine Hundred Seventy-Seven Thousand Six Hundred Pesos (Php4,977,600.00) to IEquity Technologies Corp.
