



BAC Resolution No. 2024-0212-153 (Bravo)

SUBJECT:

RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, REHABILITATION AND TESTING OF TAGAYTAY RADAR POWER TRANSFORMER AND SUBSTATION AT TAGAYTAY RADAR FACILITY.

WHEREAS, the project Rehabilitation and Testing of Tagaytay Radar Power Transformer and Substation at Tagaytay Radar Facility, an ANS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to One Million One Hundred Thousand Pesos (**PHP1,100,000.00**). A copy of the Certificate of Budget Allocation (CBA (MOOE) No. 24-05-607 dated 14 May 2024) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement was on 05 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 02 August 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-bid Conference was conducted on 12 August 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, on 29 August 2024, BAC Bravo meeting, the BAC members and BAC Bravo Technical Working Group declared a failure of the bidding under Section 35.1 (a) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that no bidders submitted their bid. A copy of the Minutes of Meeting hereto attached as *Annex "E"*;

WHEREAS, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: "The BAC shall declare the bidding a failure when no bids are received";

NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby RESOLVES, as it is hereby **RESOLVED** to recommend that the project, **REHABILITATION AND TESTING OF TAGAYTAY RADAR POWER TRANSFORMER AND SUBSTATION AT TAGAYTAY RADAR FACILITY** be declared a **FAILURE** and to return the bid documents to the end-user for mandatory review.
