

BAC Resolution No. 2024-0212-103 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, SEARCH AND RESCUE MODEL ANALYSIS PROGRAM (SARMAP) SUBSCRIPTION FOR PHILIPPINE AERONAUTICAL RESCUE COORDINATING CENTER (PARCC)

WHEREAS, the project, Search and Rescue Model Analysis Program (SARMAP) Subscription for Philippine Aeronautical Rescue Coordinating Center (PARCC), an ATS project was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Two Million Pesos (Php 2,000,000.00). A copy of the Certificate of Budget Allocation CBA (MOOE) 24-02-139 dated 02 February 2024 is herein attached as *Annex "A"*;

WHEREAS, the Change/Determination of Mode was conducted on 24 April 2024 where the end-user requested for the Change of Mode of Procurement from Competitive Bidding to Direct Contracting stating the fact that there is only one service provider for the project a position substantiated by the submitted Apostille Certificate of Sole Distributorship which the Committee, after reviewing the documents concurred. A copy of the Minutes of the Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Committee issued a Request for Quotation to One Commerce (Int'l) Corporation. on 11 June 2024 for the Notice for Direct Contracting. A copy of the Notice of Direct Contracting is hereto attached as *Annex "C"*;

WHEREAS, the Submission and Opening of bids for the project was held on 21 June 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "D" & "E", respectively*;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 24 June 2024. On the same date, the BAC-Bravo TWG presented its report indicating that One Commerce (Int'l) Corporation was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 50.c of RA 9184. The copies of said Report and Minutes of Meeting are hereto attached as *Annexes "F" & "G", respectively*;

WHEREAS, Section 50 of RA 9184 it provides that *Direct Contracting* or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:

Sec 50.c- "Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.;

NOW THEREFORE, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** through **Direct Contracting** of the project, **Search and Rescue Model Analysis Program (SARMAP) Subscription for Philippine Aeronautical Rescue Coordinating Center (PARCC)** in the total amount of **One Million Nine Hundred Ninety-Nine Thousand Nine Hundred Ninety-Nine Pesos (PHP 1,999,999.00)** to **One Commerce (Int'l) Corporation;**
