

## CCC Resolution No. 2024-047

SUBJECT: SUPPLY AND DELIVERY OF COAXIAL CABLES FOR VARIOUS ANF.

**WHEREAS**, Purchase Request/POW/CBA No. 24-06-760 dated 20 June 2024 for the Supply and Delivery of Coaxial Cables for various ANF with a total budget of P473,800.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

**WHEREAS**, on 05 July 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". **WHEREAS**, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 11 July 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and Delivery of Coaxial Cables for various ANF in the total amount of TWO HUNDRED NINETY-EIGHT THOUSAND FIVE HUNDRED EIGHTY-EIGHT PESOS (P298,588.00) only, and be AWARDED to EVERCON BUILDERS & EQUIPMENT CORPORATION, the offer of which was considered reasonable and advantageous to the Government;
