

CCC Resolution No. 2024-050

SUBJECT:

SUPPLY AND DELIVERY OF PAPER SHREDDER MACHINE FOR VARIOUS CAAP

OFFICE AT H.O.

WHEREAS, Purchase Request/POW/CBA No. 24-03-367 dated 19 March 2024 for the Supply and Delivery of Paper Shredder Machine for various CAAP Office at H.O. with a total budget of P159,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 08 April 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". Copy of the minutes hereto attached as **Annex B**;

WHEREAS, the Request for Quotation (RFQ) was posted four (4) times at a conspicuous place on the CAAP premises, CAAP, and Philgeps website on the following dates: 13 April 2024, the CCC Secretariat received no quotation; On 26 April 2024, only one (1) quotation was received and was disqualified due to non-compliance with the technical specifications; on 28 May 2024, two (2) quotations were received and both did not comply with the documentary requirements, and technical specifications; on 11 June 2024, only one (1) quotation was received and was disqualified due to non-compliance with the CAAP requirements. The project was re-posted for the fifth time on 11 July 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and Delivery of Paper Shredder Machine for various CAAP Office at H.O. in the total amount of ONE HUNDRED FIFTY-EIGHT THOUSAND FIVE HUNDRED FOURTEEN AND 4/100 PESOS (P158,514.04) only, and be AWARDED to GPL TRADING OPC the offer of which was considered reasonable and advantageous to the Government;
