BAC Resolution No. 2024-0212-146 (Bravo)

SUBJECT:

RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF TWO (2) UNITS X-RAY SCANNER (MAN-

PORTABLE)

WHEREAS, the project, Supply and Delivery of Two (2) Units X-Ray Scanner (Man-Portable) was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Twelve Million Pesos (Php12,000,000.00). A copy of the Certificate of Budget Allocation CBA (C.O) #24-04-431 dated 02 April 2024 is herein attached as Annex "A";

WHEREAS, the Pre-Procurement Conference was conducted on 17 May 2024 via inperson meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as Annex "B":

WHEREAS the Invitation to Bid (ITB) was posted on 24 May 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as Annex "C":

WHEREAS, the Pre-bid Conference was conducted on 05 June 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as Annex "D":

WHEREAS, Bid Bulletin No. 1 dated 07 June 2024, was issued for some clarification in the clarification/revision/amendments in the bidding documents of the project. A copy of the Bid Bulletin No. 01 is hereto attached as Annex "E";

WHEREAS, the Submission and Opening of bids for the project was held on 19 June 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as Annexes "F" & "G", respectively;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 20 June 2024 and was presented to the BAC on 01 July 2024, where it is indicated that the tendered bid proposal of Defense and Protection Systems Phils., Inc. to undergo Post-Qualification process for being evaluated and considered as the Lowest Calculated Responsive Bid (SCRB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. The copies of said Report and Minutes of Meeting are hereto attached as Annexes "H" & "I", respectively;

WHEREAS, the Committee issued a letter to Defense and Protection Systems Phils., dated 02 July 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "!";

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report dated 17 July 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC TWG (Bravo) recommended the Post-Disqualification of the proposal of Defense and **Protection Systems Phils.** For non-compliance with the provisions stipulated in Philippine Bidding Document under Section III Bid Data Sheet ITB Clause 5.3 and Section VI Technical Specifications Items B.2.4, C.3, C.3.1- C.3.2.4, and C.4.1 and to conduct Post-Qualification of Intelliserve Trading, Inc. for being considered as the next Lowest Calculated Bid in the amount of Eleven Million Nine Hundred Eighty Thousand Pesos (Php11,980,000.00). The copies of said Report and Minutes of Meeting are hereto attached as Annexes "K" & "L", respectively;

WHEREAS, a Notice of Post-Disqualification dated 19 July 2024 was sent to Defense and Protection System Phils., Inc informing them of their disqualification. A copy of the notice of disqualification is hereto attached as Annex "M";

WHEREAS, the Committee issued a letter to Intelliserve Trading Incorporated., dated 19 July 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as Annex "N":

WHEREAS, on 26 July 2024, the Committee received a Request for Reconsideration from Defense and Protection Phils, Inc. stating that their submitted contract for the Single Largest Completed Contract (SLCC) "Dual-View Baggage X-Ray Machines is similar to CAAP's X-Ray scanner. Moreover they stated that while the proposal did not specifically support the specific requirements under the Bill of Quantities the offer is capable of penetrating at least 37 mm steel penetration and as for the items stated under CQ.3, DPSI proposed an alternative solution to CAAP's requirement, that they will deliver an xray scanner that utilizes x-rap image plates in standard (14x17"), medium (10x12") and small (8x10") sizes, and with varied lengths(14x36" and 14x51"). WHEREAS, The Committee issued a reply to the Request for Reconsideration of Defense and Protection Systems Phils., Inc. dated 02 August 2024 denying their Request for Reconsideration. A copy of the Reply letter is hereto attached as Annex "P";

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report dated 02 August 2024 and presented it to the BAC Committee (Bravo) on the same date, wherein the BAC TWG (Bravo) recommended that the bid proposal of Intelliserve Trading, Inc. be declared as the Second Lowest Calculated and Responsive Bid (SLCRB) and that the contract be awarded to the bidder in the amount of Eleven Million Nine Hundred Eighty Thousand Pesos (Php11,980,000.00). The copies of said Report and Minutes of Meeting are hereto attached as Annexes "Q" & "R", respectively;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;

NOW THEREFORE, premises considered, the CAAP-BAC (Bravo), acting upon the recommendation of BAC-TWG (Bravo), hereby RESOLVES to APPROVE and AWARD of the project, Supply and Delivery of Two (2) Units X-Ray Scanner (Man-Portable) in the amount of Eleven Million Nine Hundred Eighty Thousand Pesos (Php11,980,000.00) to Intelliserve Trading, Inc.
