SUBJECT:

SUPPLY AND DELIVERY OF VARIOUS LABORATORY SUPPLIES.

WHEREAS, Purchase Request/POW/CBA No. 24-04-0521 dated 24 April 2024 for the Supply and Delivery of various Laboratory Supplies with a total budget of P278,840.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 17 July 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, BAC Resolution No. 2024-0212-75 dated 03 June 2024 was signed for the change of mode of procurement. Copy of the Resolution hereto attached as **Annex C**;

WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 23 July 2024, Copy of PhilGeps postings hereto attached as **Annex D**;

WHEREAS, the Request for Quotation (RFQ) was sent to the following:

- 1. METOS OFFSHORE INC.;
- 2. BEEMAX CONSUMER GOODS TRADING;
- 3. JOANNA'S LABORATORY ENTERPRISES; and
- 4. RPD CHEM ENTERPRISES:

WHEREAS, during the opening of the sealed quotations held on 26 July 2024 at the CAAP, Procurement Division Office, the CAAP-CCC noted the following:

Supplier	Price Quotation
1. A4 LUCK MARKETING CORPORATION	P260,750.00
2. BEEMAX CONSUMER GOODS TRADING	P263,885.00

WHEREAS, the end-user evaluation report submitted on 30 July 2024 disclosed that Beemax Consumer Goods Trading complied with all CAAP requirements and specifications and is considered the lowest calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex E**;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and Delivery of various Laboratory Supplies in the total amount of TWO HUNDRED SIXTY-THREE THOUSAND EIGHT HUNDRED EIGHTY-FIVE PESOS (P263,885.00) only, and be AWARDED to Beemax Consumer Goods Trading, the offer of which was considered reasonable and advantageous to the Government;
