



CCC Resolution No. 2024-057

SUBJECT: **SUPPLY AND DELIVERY OF WIRELESS AND ACQUISITION MODULE (WAM) WITH LEADS AHA CLIPS FOR TREADMILL MACHINE.**

**WHEREAS**, Purchase Request/POW/CBA No. 24-07-800 dated 01 July 2024 for the Supply and Delivery of Wireless and Acquisition Module (WAM) with Leads AHA Clips for Treadmill Machine with a total budget of P60,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

**WHEREAS**, on 17 July 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, *"Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR"*. **WHEREAS**, the Request for Quotation (RFQ) was first posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 23 July 2024, no quotation was received by the CCC Secretariat. The project was re-posted on 01 August 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

**WHEREAS**, Request for Quotation (RFQ) was sent to the following:

1. MEDICAL DEVICES CORP.;
2. MEDTRENDS DISTRIBUTORS CORP.;
3. RPD CHEM ENTERPRISES;
4. NAGALAND DEVELOPMENT CORP.; and
5. KOREECA MEDICAL SUPPLIES & TRADING;

**WHEREAS**, during the opening of the sealed RFQs held on 07 August 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

1. MEDEV MEDICAL DEVICES CORPORATION	P60,000.00

**WHEREAS**, the end-user evaluation report submitted on 12 August 2024 disclosed that MEDEV MEDICAL DEVICES CORP and complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as **Annex D**;

**WHEREAS**, Annex "H" of the Revised IRR of RA 9184, states, *"Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."*

**NOW, THEREFORE**, in consideration of the above premises, the CAAP-CCC **RESOLVES**, as it is hereby **RESOLVED** to recommend for **APPROVAL** of the Supply and Delivery of Wireless and Acquisition Module (WAM) with Leads AHA Clips in the total amount of **SIXTY THOUSAND PESOS (P60,000.00)** only, and be **AWARDED** to **MEDEV MEDICAL DEVICES CORPORATION**, the offer of which was considered reasonable and advantageous to the Government;
