RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF OFFICE AND IT SUPPLIES FOR CY 2024 AT GODOFREDO P. RAMOS AIRPORT

WHEREAS, BAC Resolution No. AREA6-GPR-SVP-2024-004-01 for the project **Supply and Delivery of Office and IT Supplies for CY 2024 at Godofredo P. Ramos Airport** with Approved Budget for the Contract (ABC) in the amount of **Two Hundred Eighty Three Thousand Seven Hundred Two Pesos & 38/100 (P 283,702.38)** hereby form the integral part of this resolution. WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Two (2) interested suppliers submitted its sealed quotation;

WHEREAS, during the Bid Opening last September 24, 2024, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Lowest Submitted Quotation with the Bid amount of **Two Hundred Thirty Three Thousand Two Hundred Ninety Seven Pesos (P 233,297.00)**;
