 RESOLUTION NO. AREA6-PB-2024-019-02**

**RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID AND
 RECOMMENDING APPROVAL FOR THE REPAINTING OF RUNWAY MARKINGS AT
 BACOLOD-SILAY AIRPORT**

WHEREAS, The Civil Aviation Authority of the Philippines advertised the Invitation to Apply for Eligibility and to Bid for the **Repainting of Runway Markings at Bacolod-Silay Airport** in the PhilGEPS, CAAP Website, and in conspicuous places at the premises of the Civil Aviation Authority of the Philippines with the ABC of **One Million Four Hundred Forty-Nine Thousand Eight Hundred Eighty-Five Pesos & 28/100 (₱ 1,449,885.28)**;

WHEREAS, in response to the said advertisement, two (2) interested bidders submitted their letter of intent and bought the bidding documents;

WHEREAS, on the day of the Preliminary Examination of Bids, two (2) bidders submitted their sealed bid proposal;

WHEREAS, during the Bid Opening last August 20, 2024, **EAJ CONSTRUCTION AND SUPPLY** was declared as the Lowest Calculated Bid with the Bid amount of **One Million Three Hundred Twenty-Three Thousand Ninety Pesos and 70/100 (₱ 1,323,090.70)**;

WHEREAS, the price quotations of the bidders were found to be substantially complying:

WHEREAS, the detailed evaluation of bids conducted resulted in the following:

WHEREAS, during the Post Qualification of Documents last September 2, 2024, the Bids and Awards Committee (BAC) verified the documents and **EAJ CONSTRUCTION AND SUPPLY** complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation, and verification of all the eligibility, technical, and financial requirements submitted, the Bidder **EAJ CONSTRUCTION AND SUPPLY** was declared as Lowest Calculated Responsive Bid;



WHEREAS, the Section 34.4 of the 2016 revised IRR of RA No. 9184 states that "If the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid passes all the criteria for post-qualification, it shall declare the said bid as the LCRB or HRRB, and recommend to the HoPE the award of contract to the said bidder at its submitted bid price or its calculated bid price, **whichever is lower** xxx."

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare **EAJ CONSTRUCTION AND SUPPLY** as the Supplier with the Lowest Calculated Responsive Bid for the project **Repainting of Runway Markings at Bacolod-Silay Airport** in the bid amount of **One Million Three Hundred Twenty-Three Thousand Ninety Pesos and 70/100 (P 1,323,090.70)**; and
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.


