WHEREAS, BAC Resolution No. BSVP-ILO 2024-050-02 for the project **Supply and Delivery of Windcone of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Twenty Five Thousand Two Hundred Pesos (₱ 25,200.00)** hereby form the integral part of this resolution.
