RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF WATER METER FOR ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-055-01 for the project **Supply and Delivery of Water Meter for Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Seventeen Thousand Five Hundred Sixty Eight Pesos (₱ 17,568.00)** hereby form the integral part of this resolution. WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, One (1) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last September 30, 2024, **UNI-FIELD ENTERPRISES INC.** was declared Single Submitted Quotation with the Bid amount of **Eleven Thousand Three Hundred Thirteen Pesos & 60/100 (₱ 11,313.60)**;


