**SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, BICOL INTERNATIONAL AIRPORT DEVELOPMENT PROJECT (COMPLETION OF AIRPORT ACCESS ROAD LIGHTING SYSTEM)**

**WHEREAS**, the project, Bicol International Airport Development Project (Completion of Airport Access Road Lighting System), an ADMS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Five Million Five Hundred Eighty-Eight Thousand Nine Hundred Two Pesos & 52/100 (**PHP5,588,902.52**). A copy of the Certificate of Allotment Release (CAR No. 2022-08-022) dated 18 August 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement Conference was conducted on 09 July 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS** the Invitation to Bid (ITB) was posted on 19 July 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, the Pre-Bid Conference was conducted on 30 July 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

**WHEREAS**, the Submission and Opening of Bids for the project was held on 13 August 2024 at the CAAP Conference Room and via video conference. The bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "E" & "F"*, respectively;

**WHEREAS**, the Bids and Awards Committee - Technical Working Group (BAC-TWG) issued its Bid Evaluation Report dated 14 August 2024 and was presented to the BAC on 15 August 2024. The calculated bid proposal of Quin Sterling Construction, Inc. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Bid (SCB) in the amount of Five Million Five Hundred Eighteen Thousand Eight Hundred Eighty-Eight Pesos & 88/100 (PHP5,518,888.88). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "G" & "H"*;





**WHEREAS**, the Committee issued a letter to Quin Sterling Construction, Inc. dated 15 August 2024 requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "I"*;

**WHEREAS**, the BAC - TWG (Alpha) issued its Post-Qualification Report dated 27 August 2024 and was presented to the BAC on 04 September 2024, wherein the BAC - TWG (Alpha) recommends that the bid proposal of Quin Sterling Construction, Inc. be declared as the Single Calculated Responsive bid (SCRB) and that the contract be awarded to the bidder for the project: Bicol International Airport Development Project (Completion of Airport Access Road Lighting System).

**WHEREAS**, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed;*

**NOW, THEREFORE**, premises considered, the **CAAP-BAC RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **Bicol International Airport Development Project (Completion of Airport Access Road Lighting System)** in the total amount Five Million Five Hundred Eighteen Thousand Eight Hundred Eighty-Eight Pesos and 88/100 (**PHP5,518,888.88**) to **Quin Sterling Construction, Inc..**
