SUBJECT:

SUPPLY AND DELIVERY OF HETTICH CENTRIFUGE ROTOFIX 32A MECHANICAL PARTS (SPEED ON THE TOP OF THE MOTOR, FUSE 15A, POWER BOARD).

WHEREAS, Purchase Request/POW/CBA No. 24-07-957 dated 27 July 2024 for the Supply and Delivery of Hettich Centrifuge Rotofix 32A Mechanical Parts (Speed on the top of the motor, Fuse 15A, Power Board) with a total budget of P81,264.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as **Annex A**;

WHEREAS, on 22 August 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, the Request for Quotation (RFQ) was posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 23 August 2024, Copy of PhilGeps postings hereto attached as **Annex C**;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

- 1. GOLDICHI INDUSTRIAL TRADE;
- 2. RPD CHEM ENTERPRISES;
- 3. OMNIBUS BIO-MEDICAL SYSTEMS INC.;
- 4. ENDURE MEDICAL INC.; and
- 5. MEDEV MEDICAL DEVICES CORPORATION;

WHEREAS, during the opening of the sealed RFQs held on 30 August 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

WHEREAS, the end-user evaluation report submitted on 04 September 2024 disclosed that OMNIBUS BIO-MEDICAL SYSTEMS INC. complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as Annex D;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply and Delivery of Hettich Centrifuge Rotofix 32A Mechanical Parts (Speed on the top of the motor, Fuse 15A, Power Board) in the total amount of EIGHTY-ONE THOUSAND TWO HUNDRED SIXTY-FOUR PESOS (P81,264.00) only, and be AWARDED to OMNIBUS BIO-MEDICAL SYSTEMS INC. the offer of which was considered reasonable and advantageous to the Government;
