SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PROCUREMENT OF CERTIFICATION SERVICES FOR CAAP- FLIGHT STANDARDS INSPECTORATE SERVICE (FSIS) QUALITY MANAGEMENT SYSTEM UNDER ISO 9001: 2015 QUALITY MANAGEMENT SYSTEM (QMS)

WHEREAS, the project, Procurement of Certification Services for CAAP Flight Standards Inspectorate Service (FSIS) Quality Management System Under ISO 9001:2015 Quality Management System (QMS), an ODG-SQMO was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of **Five Hundred Thousand Pesos (Php500,000.00)**. A copy of the Certificate of Budget Allocation (CBA (MOOE) 24-03-338 dated 08 March 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 24 April 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 14 June 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, the Pre-bid Conference was conducted on 24 June 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of bids for the project was held on 08 July 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A Lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively*;

WHEREAS, the Bids and Awards Committee Technical Working Group (Bravo) issued its Bid Evaluation Report dated 17 July 2024 and was presented to the BAC on the same day, where it is indicated that the tendered bid proposal of Certification International Philippines Inc. to undergo Post-Qualification process for being evaluated and considered as the Single Calculated Responsive Bid (SCRB) and to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents. WHEREAS, the Committee issued a letter to Certification International Philippines Inc., dated 19 July 2024, requiring them to submit additional requirements for Post-Qualification. A copy of the letter is hereto attached as *Annex "I"*;

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report dated 29 July 2024 and presented it to the BAC Committee (Bravo) on the same day, wherein the BAC TWG (Bravo) recommended that the bid proposal of **Certification International Philippines Inc.** to be declared as the Single Calculated Responsive Bid (SCRB) in the amount of **Four Hundred Fifty-Three Thousand Six Hundred Pesos (Php453,600.00)** for the project **Procurement of Certification Services for CAAP Flight Standards Inspectorate Service (FSIS) Quality Management System Under ISO 9001:2015 Quality Management System (QMS)**. The copy of said Report and Minutes of Meeting are hereto attached as *Annexes "J" & "K", respectively*;

WHEREAS, the BAC TWG-Bravo recommended for the award of the project to **Certification International Philippines Inc.**, in the amount of **Four Hundred Fifty-Three Thousand Six Hundred Pesos (Php453,600.00)**.

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRБ, or SRRB after the post-qualification process has been completed.*;

NOW THEREFORE, premises considered, the **CAAP-BAC (Bravo)**, acting upon the recommendation of BAC-TWG (Bravo), hereby **RESOLVES** to **APPROVE** and **AWARD** of the project, Procurement of Certification Services for CAAP Flight Standards Inspectorate Service (FSIS) Quality Management System Under ISO 9001:2015 Quality Management System (QMS) in the amount of **Four Hundred Fifty-Three Thousand Six Hundred Pesos (Php453,600.00)** to **Certification International Philippines Inc.**
