Further, the prospective suppliers should possess the following:

1. Should have the legal capacity to enter into business or to perfect contracts (with updated Business Permit from DTI and recent Tax Certification from BIR as per Section 8.5 of Section 8.0 of Rule III and as per sub-paragraph a.ii of Section 24.1 of Section 24 of Rule VIII of the Revised IRR of RA 9184 and GPPB Resolution No. 11-2013 dated April 26, 2013);
2. PhilGeps Registration (At least Red Membership)
3. Notarized Omnibus Sworn Statement
4. Certificate of Product registration from food and Drug Administration (FDA)
5. Certificate of Good Manufacturing Practice from (FDA)
6. Batch Release Certificate from (FDA)
7. If the Supplier is not the manufacturer, Certification from the Manufacturer that the supplier is an Authorized distributor/Dealer of the Product/Items
8. Should not be among those blacklisted suppliers. (as per sub- sub-paragraph a.iv (1) of Section 25.2 of Section 25 of Rule VIII of the Revised IRR of RA 9184 and Section 2 of GPPB's UNIFORM GUIDELINES FOR BLACKLISTING OF MANUFACTURERS, SUPPLIERS, DISTRIBUTORS, CONTRACTORS AND CONSULTANTS)
