



BAC Resolution No. 2024-0910-178 (Bravo)

SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, PURCHASE OF GNSS EQUIPMENT, SOFTWARE, AND ITS ACCESSORIES.

WHEREAS, the project Purchase of GNSS Equipment, Software, and its Accessories, an ADMS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to Fifteen Million Pesos (PHP15,000,000.00). A copy of the Certificate of Budget Allocation (CBA (C.O) No. 24-01-013 dated 09 January 2024) is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement was on 31 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Invitation to Bid (ITB) was posted on 16 August 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, The Committee issued a Bid Bulletin No. 01, dated 16 August 2024, which contained a new schedule for Pre-bid Conference. A copy of the Bid Bulletin No. 1 is hereto attached as *Annex "D"*;

WHEREAS, the Committee issued a Notice of Postponement dated 28 August 2024, rescheduling the meeting for all agenda items, including the Pre-Bid Conference, to 29 August 2024. A copy of a Notice of Postponement is hereto attached as *Annex "E"*;

WHEREAS, Pre-bid Conference was conducted on 29 August 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of Bids for the project was held on 09 September 2024 at the CAAP Conference Room via in-person meeting and Google Meet Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "G" & "H", respectively*;

Bidder/s	Remarks
Argotek, Inc.	Disqualified -Submitted bid is higher than the ABC of the project.

WHEREAS, the BAC TWG recommended for declaration of failure of the said project and was adopted by the Committee;

WHEREAS, Section 35.1 (b) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when all prospective bidders are declared ineligible."*





NOW THEREFORE, the CAAP-BAC BRAVO acting upon the recommendation of the BAC TWG hereby **RESOLVES**, as it is hereby **RESOLVED** to recommend that the project, **PURCHASE OF GNSS EQUIPMENT, SOFTWARE, AND ITS ACCESSORIES** be declared a **FAILURE** and to return the bid documents to the end-user for mandatory review;
