



*BAC Resolution No. 2024-0910-172 (Bravo)*

**SUBJECT: RECOMMENDING THE FAILURE OF BIDDING FOR THE PROJECT ENTITLED, SUPPLY AND DELIVERY OF FIFTEEN (15) HEADSETS FOR MANILA ACC AND FIFTEEN (15) UNITS FOR MANILA AMS.**

**WHEREAS**, the project Supply and Delivery of Fifteen (15) Headsets for Manila ACC and Fifteen (15) Units for Manila AMS, an ATS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to Two Million Four Hundred Thousand Pesos (**Php2,400,000.00**). A copy of the Certificate of Budget Allocation (CBA (C.O) No. 24-05-572 dated 06 May 2024) is herein attached as *Annex "A"*;

**WHEREAS**, the Pre-Procurement was on 10 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

**WHEREAS**, the Invitation to Bid (ITB) was posted on 14 August 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

**WHEREAS**, The Committee issued a Bid Bulletin No. 01 dated 16 August 2024, which contained the new schedule for Submission and Opening of Bids. A copy of the Bid Bulletin No. 1 is hereto attached as *Annex "D"*;

**WHEREAS**, the Committee issued a Notice of Postponement dated 28 August 2024, rescheduling the meeting for all agenda items, including the Pre-Bid Conference, to 29 August 2024. A copy of a Notice of Postponement is hereto attached as *Annex "E"*;

**WHEREAS**, Pre-bid Conference was conducted on 29 August 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "F"*;

**WHEREAS**, the Committee issued a Bid Bulletin No. 02 dated 05 September 2024, which comprised replies to the bidder/s questions during the pre-bid conference, along with the rescheduling of the Submission and Opening of Bids. A copy of the Bid Bulletin No. 2 is hereto attached as *Annex "G"*;

**WHEREAS**, the Committee received a Notice of Withdrawal from Philcox (Philippines), Inc. dated 18 September 2024. A copy of the Notice is hereto attached as *Annex "H"*;

**WHEREAS**, On September 18, 2024, during the Submission and Opening of Bids at the BAC Bravo meeting, the BAC members and TWG declared a bidding failure under Section 35.1 (a) of the Revised Implementing Rules and Regulations of Republic Act 9184, considering that no bidders submitted their bid. A copy of the Minutes of Meeting is hereto attached as *Annex "I"*;

**WHEREAS**, Section 35.1 (a) of the Revised Implementing Rules and Regulations of RA 9184 provides that: *"The BAC shall declare the bidding a failure when no bids are received"*;
