



BAC Resolution No. 2024-0910-168 (Bravo)

SUBJECT: RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, SUPPLY AND INSTALLATION OF RUNWAY THRESHOLD/END INSET LIGHTS AT KALIBO INTERNATIONAL AIRPORT.

WHEREAS, the project, Supply and Installation of Runway Threshold/End Inset Lights at Kalibo International Airport, an ANS project was forwarded to the Bids and Awards Committee – Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Five Million Three Hundred Seventy-Nine Thousand One Hundred Thirty Pesos (**PHP5,379,130.00**). A copy of the Certificate of Budget Allocation CBA (MOOE) No. 24-04-432 dated 02 April 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 26 June 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 12 July 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Invitation to Bid is hereto attached as *Annex "C"*;

WHEREAS, the Pre-Bid Conference was conducted on 19 July 2024 via in-person meeting and Google Meet Video Conference. A copy of the Minutes of Meeting is hereto attached as *Annex "D"*;

WHEREAS, the Committee received a clarification letter from Evercon Builders & Equipment Corporation dated 20 July 2024. A copy of the said letter is hereto attached as *Annex "E"*;

WHEREAS, the Committee issued a Bid Bulletins 1 and 2 on 30 July 2024, the former of which contained a response to the clarification letter of Evercon Builders & Equipment Corporation and the latter of which included a new schedule for the Submission and Opening of the Bids. The copies of the Bid Bulletins are hereto attached as *Annex "F"*;

WHEREAS, the Submission and Opening of bids for the project was held on 09 August 2024 at the CAAP Conference Room and via video conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of Meeting and Abstract of Bids as Read are hereto attached as *Annexes "G" & "H", respectively*;

WHEREAS, the Bids and Awards Committee Technical Working Group – Bravo (BAC TWG - Bravo) issued its Bid Evaluation Report dated 12 August 2024 and was presented to the BAC on the 14 August 2024, where it is indicated that the bid proposal of Evercon Builders & Equipment Corporation is recommended to be declared as Single Calculated Bid (SCB) in the amount of Five Million Three Hundred Sixty-Eight Thousand Eight Hundred Thirty-Four Pesos & 80/100 (PHP5,368,834.80) and subject its bid proposal for Post-Qualification. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "I" & "J"*,

WHEREAS, the Committee issued a letter to Evercon Builders & Equipment Corporation dated 14 August 2024, requiring the same to submit the necessary additional requirements for Post-Qualification. A copy of the said letter is hereto attached as *Annex "K"*,

WHEREAS, the Committee issued a Notice of Postponement dated 28 August 2024, rescheduling the meeting for all agenda items, including this project's Post-Qualification Report, to 29 August 2024. A copy of a Notice of Postponement is hereto attached as *Annex "L"*,

WHEREAS, the BAC TWG (Bravo) issued its Post-Qualification Report dated 28 August 2024 and was presented to the BAC on 29 August 2024, wherein the BAC TWG (Bravo) recommended that the bid proposal of Evercon Builders & Equipment Corporation be declared as the Single Calculated & Responsive Bid (SCRB) and that the contract be awarded to the bidder in the amount of Five Million Three Hundred Sixty-Eight Thousand Eight Hundred Thirty-Four Pesos & 80/100 (Php5,368,834.80). The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "M" & "N", respectively*;

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRБ, or SRRB after the post-qualification process has been completed.*;

NOW, THEREFORE, premises considered, the **CAAP-BAC (BRAVO) RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, Supply and Installation of Runway Threshold/End Inset Lights at Kalibo International Airport in the total amount of Five Million Three Hundred Sixty-Eight Thousand Eight Hundred Thirty-Four Pesos & 80/100 (**PHP5,368,834.80**) to **Evercon Builders & Equipment Corporation**.




