## CCC Resolution No. 2024-063

SUBJECT:

SUPPLY, DELIVERY, INSTALLATION/REPLACEMENT AND COMMISSIONING OF TWO (2) UNITS OF OIL PRESSURE UNIT OF 775KVA DEGS AT MANILA CNS/ATM FACILITY.

WHEREAS, Purchase Request/POW/CBA No. 24-04-490 dated 18 April 2024 for the Supply, Delivery, Installation/Replacement and Commissioning of two (2) units of Oil Pressure Unit of 775KVA DEGS at Manila CNS/ATM Facility with a total budget of P100,000.00 was approved for procurement. Copy hereto attached and made an integral part of this Resolution as Annex A;

WHEREAS, on 05 July 2024, CAAP-CCC, agreed to bid this project through Negotiated Procurement, employing IRR-A Section 53.9 Small Value Procurement, "Procurement of Goods, Infrastructure Projects and Consulting Services, where the amount involved does not exceed the threshold prescribed in Annex "H" of this IRR, Provided, That in case of Goods, the procurement does not fall under shopping in Section 52 of this IRR". WHEREAS, BAC Resolution No. 2024-0212-67 dated 20 May 2024 was signed for the change of mode of procurement. Copy of the Resolution hereto attached as **Annex C**;

WHEREAS, the Request for Quotation (RFQ) was first posted at a conspicuous place on the CAAP premises, CAAP, and PhilGeps website on 23 July 2024, no quotation was received by the CCC Secretariat. The project was re-posted on 11 August 2024, Copy of PhilGeps postings hereto attached as Annex D;

WHEREAS, Request for Quotation (RFQ) was sent to the following:

- 1. GOLDICHI INDUSTRIAL TRADE;
- 2. WEST POINT ENGINEERING SUPPLIES;
- 3. GBB TECH ELECTRO MECHANICAL DEVELOPMENT INC.;
- 4. KILTON MOTOR SERVICES; and
- 5. LSI LEADING TECHNOLOGIES;

WHEREAS, during the opening of the sealed RFQs held on 19 August 2024 at the CAAP, Procurement Division Office, only one (1) supplier submitted a quotation, as follows:

WHEREAS, the end-user evaluation report submitted on 27 August 2024 disclosed that Trade Venture International Corporation complied with all CAAP requirements and specifications and is considered the single calculated and responsive quotation. Copy of the Evaluation hereto attached as Annex E;

WHEREAS, Annex "H" of the Revised IRR of RA 9184, states, "Award of Contract in favor of the supplier with the Lowest Calculated and Responsive Quotation."

NOW, THEREFORE, in consideration of the above premises, the CAAP-CCC RESOLVES, as it is hereby RESOLVED to recommend for APPROVAL of the Supply, Delivery, Installation/Replacement and Commissioning of two (2) units of Oil Pressure Unit of 775KVA DEGS at Manila CNS/ATM Facility in the total amount of NINETY-EIGHT THOUSAND PESOS (P98,000.00) only, and be AWARDED to Trade Venture International Corporation, the offer of which was considered reasonable and advantageous to the Government;
