RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL FOR SUPPLY AND DELIVERY OF TONER FOR THE PHOTOCOPIER OF HR UNIT OF ILOILO INTERNATIONAL AIRPORT
