WHEREAS, BAC Resolution No. BSVP-ILO 2024-048-05 for the project **Rehabilitation of Comfort Room at Paid Parking Area at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Seventy Four Thousand Nine Hundred Seventy Six Pesos & 21/100 (₱ 174,976.21)** hereby form the integral part of this resolution.
