WHEREAS, BAC Resolution No. BSVP-ILO 2024-058-01 for the project **Repair and Maintenance of Ambulance at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Eight Thousand One Hundred Ninety Six Pesos & 43/100 (₱ 108,196.43)** hereby form the integral part of this resolution. 
