



BAC Resolution No. BSVP-ILO 2024-061-02

RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF FIREFIGHTING BOOTS AND FIREFIGHTING HOOD FOR ARFF FIREFIGHTING USE AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-061-01 for the project **Supply and Delivery of Firefighting Boots and Firefighting Hood for ARFF Firefighting Use at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **One Hundred Thirty Thousand Five Hundred Pesos (₱ 130,500.00)** hereby form the integral part of this resolution. A copy is herewith attached as Annex A;

WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

WHEREAS, Three (3) interested supplier submitted its sealed quotation;

WHEREAS, during the Bid Opening last October 16, 2024, **JMS RESCUE SUPPLIES & EQUIPMENT TRADING** was declared as the Single Submitted Quotation with the Bid amount of **Ninety Seven Thousand Five Hundred Pesos (₱ 97,500.00)**;

WHEREAS, the price quotation of the bidder was found to be substantially compliant:

WHEREAS, bid submitted by the following bidders:

- a) **PEPSAN ENTERPRISES** has been disqualified due to: submitted Omnibus Sworn Statement was **NOT** duly notarized.

In Section 25.3a of the 2016 revised IRR of RA No. 9184 states that *"The signatory is the duly authorized representative of the prospective bidder, and granted full power and authority to do, execute and perform any and all acts necessary to participate, submit the bid, and to sign and execute the ensuing contract accompanied by the **duly notarized** Special Power of Attorney, Board/Partnership Resolution, or Secretary's Certificate, whichever applicable."*

- b) **FIRST INDUSTRY COMPANY** has been disqualified during the bid opening due to Non-submission of eligibility requirements as stated in the Request for Quotation:



1. Special Power of Attorney for Sole Proprietorship/ Secretary Certificate for Corporation and Cooperative

In Section 30.1. of the 2016 revised IRR of RA No.9184 "The BAC shall open the first bid envelopes in public to determine each bidder's compliance with the documents required to be submitted for eligibility and for the technical requirements, as prescribed in this IRR. For this purpose, the BAC shall check the submitted documents of each bidder against a checklist of required documents to ascertain if they are all present, using a non-discretionary "pass/fail" criterion, as stated in the Instructions to Bidders. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, the detailed evaluation of quotations conducted resulted in the following:

WHEREAS, during the Post Qualification of Documents last October 25, 2024, Bids and Awards Committee (BAC) verified the documents and **JMS RESCUE SUPPLIES & EQUIPMENT TRADING** complied with the requirements as stated in the Notice for Post Qualification Evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the Bidder, **JMS RESCUE SUPPLIES & EQUIPMENT TRADING** as found to be the Single Calculated Responsive Quotation;

NOW THEREFORE, the Members of the Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED:

- a) To declare, **JMS RESCUE SUPPLIES & EQUIPMENT TRADING** as the Supplier with the Single Calculated Responsive Quotation for the project **Supply and Delivery of Firefighting Boots and Firefighting Hood for ARFF Firefighting Use at Iloilo International Airport** in the bid amount of **Ninety Seven Thousand Five Hundred Pesos (₱ 97,500.00)**;
- b) To recommend for approval by the Head of the Procuring Entity of the Civil Aviation Authority of the Philippines the foregoing findings.
