RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF GARDENING SUPPLIES FOR 2024 AT ILOILO INTERNATIONAL AIRPORT

WHEREAS, BAC Resolution No. BSVP-ILO 2024-063-01 for the project **Supply and Delivery of Gardening Supplies for 2024 at Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Seventy Seven Thousand Ten Pesos & 88/100 (₱ 77,010.88)** hereby form the integral part of this resolution. WHEREAS, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

WHEREAS, during the Bid Opening last October 28, 2024, **MCARV OFFICE AND SCHOOL SUPPLY AND EQUIPMENT** was declared Single Submitted Quotation with the Bid amount of **Seventy Six Thousand Three Hundred Eighty Pesos (₱ 76,380.00)**;
