RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF IT SUPPLIES FOR THE MONTH OF OCTOBER TO DECEMBER 2024 OF ILOILO INTERNATIONAL AIRPORT
