



**BAC Resolution No. BSVP-ILO 2024-069-02**

**RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL OF SUPPLY AND DELIVERY OF JANITORIAL SUPPLIES FOR THE MONTH OF DECEMBER 2024 OF ILOILO INTERNATIONAL AIRPORT**

**WHEREAS**, BAC Resolution No. BSVP-ILO 2024-069-01 for the project **Supply and Delivery of Janitorial Supplies for the month of December 2024 of Iloilo International Airport** with Approved Budget for the Contract (ABC) in the amount of **Five Hundred Seventy Nine Thousand Two Hundred Thirty Pesos (₱ 579,230.00)** hereby form the integral part of this resolution. **WHEREAS**, Three (3) Request for Quotations (RFQ) were distributed to different suppliers;

**WHEREAS**, Acknowledgement Receipts are herewith attached as proof that copies of Request for Quotation (RFQ) were distributed;

**WHEREAS**, Two (2) interested suppliers submitted its sealed quotation;

**WHEREAS**, during the Bid Opening last November 19, 2024, **NEW ILOILO IZEEM COMMERCIAL SUMMIT INC.** was declared Single Submitted Quotation with the Bid amount of **Five Hundred Seventy Thousand Six Hundred Fifty Pesos (₱ 570,650.00)**;

**WHEREAS**, the price quotation of the bidder was found to be substantially compliant:


