



BAC Resolution No. 2024-0212-64 (Alpha)

**SUBJECT: FAILURE OF BIDDING OF THE PROJECT ENTITLED,
PROCUREMENT OF IMPROVEMENT/ RENOVATION OF 4th
FLOOR CAAP ADMIN BUILDING
(Bid No. 24-018-04 ALPHA)**

WHEREAS, the project, Procurement of Improvement/ Renovation of 4th Floor CAAP Admin Building with Bid No. 24-018-04 Alpha, an ADMS project was forwarded to the Bids and Awards Committee – Alpha of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Seventeen Million Seven Hundred Eighty- Four Thousand Sixty-Two Pesos & 32/100 (P17,784,062.32). A copy of the Certificate of Budget Allocation (CBA 24-02-231 dated 16 February 2024 is herein attached as *Annex "A"*;

WHEREAS, the Pre-Procurement Conference was conducted on 26 March 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS the Invitation to Bid (ITB) was posted on 12 April 2024 on the Phil-GEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. copy of the Invitation to Bid is attached hereto as *Annex "C"*;

WHEREAS, Pre-bid Conference was conducted on 23 April 2024 via Google Meet Video Conference. Copy of the Minutes of Meeting hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of bids for the project was held on 07 May 2024 at the CAAP Conference Room via In-person Meeting and video conference. Bidders submitted their bid proposals for the project, and the following results were noted. Copy of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively*;

Profugo Construction & Supply, Peter John Construction & Supply, CATS Enterprise, M&P Worldwide Solutions, Inc., Big J Steel Construction Corporation and D&D Engineering Services, Co. for offering an "INCOMPLETE BID" specifically on the non-compliance with WAGE ORDER NO. NCR-24 and submission of deficient list of materials required in the detailed estimates of the bidding documents. NOW THEREFORE, premises considered, the CAAP-BAC (Alpha), hereby **RESOLVES** to declare the project, Procurement of Improvement/ Renovation of 4th Floor CAAP Admin Building a **FAILURE** and Re-Bidding to ensue.
