



*BAC Resolution No. 2024-0212-94 (Bravo)*

**SUBJECT: RECOMMENDING FOR THE APPROVAL OF HOPE THROUGH NEGOTIATED PROCUREMENT FOR EMERGENCY CASES OF THE PROJECT ENTITLED, EXTENSION OF CONTRACT FOR THE LEASE OF AIRCRAFT FOR CAAP-FICG FLIGHT OPERATIONS MISSION NATIONWIDE**

**WHEREAS**, the project, Extension of Contract for the Lease of Aircraft for CAAP-FICG flight Operations Mission Nationwide, an ODG-FICG project was forwarded to the Bids and Awards Committee- Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Nine Million Nine Hundred Twenty-One Thousand Eight Hundred Pesos (Php 9,921,800.00). A copy of the Certificate of Budget Allocation (CBA (MOOE) 24-05-644 dated 21 May 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Committee received a memorandum from the end-user dated 31 May 2024 requesting for the possible revision of this procurement into an alternative method by Negotiated Procurement for Emergency Cases indicating that there exists the necessity for immediate flight inspection activities to prevent possible damage and loss of life or property that may be caused by defective facilities. That it is necessary to restore and preserve the public services of airports and navigational aids through prompt calibration and inspection and that all these measures are needed to prevent social and economic disruption in our airport localities. A copy of the memorandum is hereto attached as *Annex "B"*;

**WHEREAS**, the Committee issued a Request for Quotation to Asian Aerospace Corporation and SMS Global Technologies, Inc. on June 11 2024 for the Notice for Negotiated Procurement (Emergency Cases). A copy of the notice is hereto attached as *Annex "C"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on June 19, 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "D" & "E", respectively*;


**WHEREAS**, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 24 June 2024. On the same date, the BAC-Bravo TWG presented its report indicating that Asian Aerospace Corporation was determined legally, technically, and financially capable to address the emergency and ascertained "COMPLIANT", under Sec 53.2 of RA 9184. The copies of said Report and Minutes of Meeting are hereto attached as Annexes "F" & "G", respectively;

**WHEREAS**, Sec 53.2 of RA 9184 it provides that *"In case of imminent danger to life and property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities. The instances or situations where the foregoing conditions may be applied include the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease and other negative effects on human, physical, mental and social well-being together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation.;*

**NOW THEREFORE**, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, **NEGOTIATED PROCUREMENT FOR EMERGENCY CASES FOR LEASE OF AIRCRAFT FOR CAAP-FICG FLIGHT OPERATIONS MISSION NATIONWIDE**, to **ASIAN AEROSPACE CORPORATION** in the total amount of **Nine Million Nine Hundred Twenty-One Thousand Eight Hundred Pesos (Php 9,921,800.00)**;


