**SUBJECT: RECOMMENDING THE AWARD OF THE PROJECT ENTITLED, LEASE OF VENUE FOR THE 59<sup>TH</sup> DIRECTOR GENERALS OF CIVIL AVIATION (DGCA) CONFERENCE DINNER FOR OCTOBER 15, 2024**

**WHEREAS**, the project, Lease of Venue for the 59<sup>th</sup> Civil Aviation Director Generals of Civil Aviation (DGCA) Conference Dinner for October 15, 2024, an ODG project, was forwarded to the Bids and Awards Committee - Bravo of CAAP (CAAP-BAC Bravo) for its procurement. The project has an approved budget of One Million One Hundred Twenty-Five Thousand Pesos (Php1,125,000.00). A copy of the Certificate of Budget Allocation (CBA (MOOE) No. 24-08-1041 dated 15 August 2024 is herein attached as *Annex "A"*;

**WHEREAS**, the Committee issued a Notice of Negotiated Procurement and Request for Quotation dated 14 August 2024 to Sheraton Mactan Cebu Resort, NU Star Cebu, and Shangri-la Mactan Cebu. The copies of the letters are hereto attached as *Annexes "B", "C", & "D" respectively*;

**WHEREAS**, Bid Bulletin No. 01, dated 16 August 2024, was issued for the re-scheduling of the Opening and Submission of Bids for the project. A copy of Bid Bulletin No. 01 is hereto attached as *Annex "E"*;

**WHEREAS**, the Submission and Opening of bids for the project was held on 29 August 2024 at the CAAP Conference Room via in-person meeting and video conference. Bidders submitted their bid proposals for the project, and the following results were noted. The copies of the Minutes of the Meeting and Abstract of Bids as Read are hereto attached as *Annexes "F" & "G", respectively*;

**WHEREAS**, the BAC TWG (Bravo) issued its Bid Evaluation Report dated 12 September 2024 and presented it to the BAC Committee (Bravo) on 16 September 2024, wherein the BAC TWG (Bravo) recommended the bid proposal of **Sheraton Cebu Mactan Resort (Appleone Mactan Inc.)** be declared as the Lowest Calculated and Responsive Bid (LCRB) in the amount of **One Million One Hundred Twenty-Five Thousand Pesos (Php1,125,000.00)**. **WHEREAS**, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;*

**NOW THEREFORE**, premises considered, the **CAAP-BAC (Bravo)**, acting upon the recommendation of BAC-TWG (Bravo), hereby **RESOLVES** to **APPROVE** and **AWARD** of the project, Lease of Venue for the 59<sup>th</sup> Civil Aviation Director Generals of Civil Aviation (DGCA) Conference Dinner for October 15, 2024, in the amount of **One Million One Hundred Twenty-Five Thousand Pesos (Php1,125,000.00)** to **Sheraton Cebu Mactan Resort (Appleone Mactan Inc.)**
