RECOMMENDING THE AWARD OF BIDDING OF THE PROJECT ENTITLED, PROCUREMENT OF PAGADIAN AIRPORT DEVELOPMENT PROJECT -(PHASE II) (NEGOTIATED PROCUREMENT)

WHEREAS, the project, Procurement of Pagadian Airport Development Project - (Phase II), an ADMS project was forwarded to the Bids and Awards Committee of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Forty-Eight Million Four Hundred Ninety-Two Thousand Eight Hundred Eighty-One Pesos & 17/100 (PHP48,492,881.17). A copy of the Certificate of Allotment Release CAR No. 2024-04-014 dated 13 April 2024 is herein attached as Annex "A";

WHEREAS, the recommended Mode of Procurement adopted for this project is Negotiated Procurement under Section 53.4 (Adjacent or Contiguous) of the Revised IRR of R.A. No. 9184;

WHEREAS, Sec. 53.4 of the Revised IRR of R.A 9184 provides that: Where the subject contract is adjacent or contiguous to an ongoing Infrastructure Project or Consulting Service where the consultants have unique experience and expertise to deliver the required service;



WHEREAS, the Committee issued a Bid Bulletin No. 01 dated 06 August 2024, rescheduling the Submission and Opening of the Bids. A copy of the Bid Bulletin No. 01 is hereto attached as Annex "C":

WHEREAS, the Submission and Opening of bids for the project was held on 15 August 2024 at the CAAP Conference Room and via video conference. The bidder submitted their bid proposals for the project, and the following results were noted. 
