  - 5.3 Name/credentials of proposed one (1) Mechanical / Electrical Engineer, four (4) Electrical / Mechanical Technicians and two (2) Assistant Technicians.
  - 5.4 List of Contractor's Equipment, including proof of ownership or certification of availability of the Basic Tools, Special Tools, Power Tools, Multi Tester / Clamp Ammeter, Vacuum Cleaner and Scaffolding from the lessor/vendor for the duration of the project, as the case may be.

- 6.2.1 Latest Income Tax Return (ITR) shall be the ITR for the preceding year, whether calendar or fiscal duly stamped received by the BIR; and
- 6.2.2 Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, Opening & Preliminary Examination of Bids filed through the Electronic Filing & Payment System (EFPS).

**Quotations not accompanied by current Mayor's/Business Permit; Phil-GEPS Registration Number; name/credentials of proposed Mechanical/Electrical Engineer, Electrical/Mechanical Technicians and Assistant Technicians; and List of Contractor's Equipment, including proof of ownership or certification of availability of Basic Tools, Special Tools, Power Tools, Multi Tester / Clamp Ammeter, Vacuum Cleaner and Scaffolding from the lessor/vendor for the duration of the project, as the case may be, shall be automatically disqualified.**
