



BAC Resolution No. 2024-0212-76 (Alpha)

SUBJECT: RECOMMENDING THE AWARD OF BIDDING FOR THE PROJECT ENTITLED, PROCUREMENT OF RELOCATION OF DISTRIBUTION AND METERING FACILITIES AT CAAP COMPOUND.

WHEREAS, the project, Procurement of Relocation of Distribution and Metering Facilities at CAAP Compound, an ADMS project was forwarded to the Bids and Awards Committee – Alpha of the Civil Aviation Authority of the Philippines (CAAP-BAC Alpha) for its procurement. The project has an approved budget of Three Million Six Hundred Seven Thousand Nine Hundred Seventy Pesos & 42/100 (PHP3,607,970.42). A copy of the Certificate of Budget Allocation CBA (C.O) No. 24-04-453 dated 04 April 2024 is herein attached as *Annex "A"*;

WHEREAS, the recommended mode of procurement adopted for this project is Negotiated Procurement under Section 53.4 (Adjacent or Contiguous) of the Revised IRR of R.A. No. 9184, which provides that: *Where the subject contract is adjacent or contiguous to an ongoing Infrastructure Project or Consulting Service where the consultants have unique experience and expertise to deliver the required service;*

WHEREAS, the Pre-Procurement Conference was conducted on 07 May 2024 via Google Meet Video Conference. A copy of the Minutes of Meeting hereto attached as *Annex "B"*;

WHEREAS, the Committee issued a Letter for Negotiation to Durabuild Construction dated 13 May 2024. A copy of the Negotiated Letter is attached hereto as *Annex "C"*;

WHEREAS, the Submission and Opening of bids for the project was held on 23 May 2024 at the CAAP Conference Room via in-person meeting and video conference. Durabuild Construction submitted their bid proposal for the project, and the following results were noted. A copy of the Minutes of the Meeting and Abstract of Bids as Read are hereto attached as *Annexes "D" & "E", respectively;*

WHEREAS, the Bids and Awards Committee Technical Working Group (Alpha) issued its Bid Evaluation Report dated 28 May 2024 and was presented to the BAC Alpha on the same day, where it is recommended to award the contract to **Durabuild Construction** in the amount of THREE MILLION FIVE HUNDRED FIFTY THOUSAND PESOS ONLY (PHP3,550,000.00) for the project of PROCUREMENT OF RELOCATION OF DISTRIBUTION

WHEREAS, Section 37.1.1 of 2016 IRR of RA 9184 provides that: *The BAC shall recommend to the HoPE the award of contract to the bidder with the LCRB, HRRB, SCRB, or SRRB after the post-qualification process has been completed.;*

NOW, THEREFORE, premises considered, the **CAAP-BAC RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** of the project, Procurement of Relocation of Distribution & Metering Facilities at CAAP Compound in the total amount of Three Million Five Hundred Fifty Thousand Pesos Only (**PHP3,550,000.00**) to **Durabuild Construction**.
