



BAC Resolution No. 2024-0910-165 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT ENTITLED, PROCUREMENT OF SPARE PARTS FOR VSAT COMMUNICATIONS SYSTEM UNDER THE CNS/ATM.

WHEREAS, the project, Procurement of Spare Parts for VSAT Communications System under the CNS/ATM, an ANS project was forwarded to the CAAP Bids and Awards Committee (Bravo) for its procurement. The project has an approved budget amounting to Fourteen Million Eight Hundred Sixty-Two Thousand Four Hundred Seventy-Three Pesos & 92/100 (**PHP14,862,473.92**). A copy of the Certificate of Budget Allocation (CBA (MOOE) No. 24-07-809 dated 02 July 2024) is herein attached as *Annex "A"*;

WHEREAS, on 14 August 2024, at the meeting of BAC Bravo, the end-user requested the mode of procurement be done through Direct Contracting. The determination of mode after checking the documents was approved by the committee. A copy of the Minutes of Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Request for Quotation (RFQ) was posted on 19 August 2024 on the PhilGEPS, CAAP Official Website, and other conspicuous places on the CAAP premises. A copy of the Request for Quotation is attached hereto as *Annex "C"*;

WHEREAS, the Committee issued a Notice of Postponements dated 02 and 03 September 2024, rescheduling the meeting for all agenda items, including the Submission and Opening of bids for aforementioned project, to 04 September 2024. The copies of the Notice of Postponements are hereto attached as *Annexes "D" & "E"*, respectively;

WHEREAS, the Submission and Opening of bids for the project was held on 04 September 2024 at the CAAP Conference Room via in-person meeting and video conference. We are I.T Phils., Inc. submitted their bid proposal for the project, and the following result was noted. A copy of the Minutes of Meeting and Bidding Checklist are hereto attached as *Annexes "F" & "G"*, respectively;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 06 September 2024. On the same date, the BAC-Bravo TWG presented its report indicating that We are I.T Phils., Inc. was determined technically, legally, and financially capable to deliver the goods at the most advantageous price and contract, under Sec 50.c of RA 9184. The copies of the said Report and Minutes of Meeting are hereto attached as *Annexes "H" & "I"*, respectively;

WHEREAS, **Section 50 of RA 9184** it provides that *Direct Contracting or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some*

negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions

Sec 50.c- "Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.;

NOW THEREFORE, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** through **Direct Contracting** of the project, **Procurement of Spare Parts for VSAT Communications System under the CNS/ATM** in the total amount of **Fourteen Million Seven Hundred Sixty-Two Thousand Four Hundred Seventy-Three Pesos & 92/100 (PHP14,762,473.92)** to **We are I.T Phils., Inc.**


