BAC Resolution No. 2024-0910-199 (Bravo)

SUBJECT: RECOMMENDING THE AWARD FOR THE PROJECT PROVISION OF MAINTENANCE SERVICE FOR THE AERODROME CONTROL TOWER SIMULATOR INSTALLED AT CATC AND MANILA CONTROL TOWER.

WHEREAS, the project, Provision of Maintenance Service for the Aerodrome Control Tower Simulator installed at CATC and Manila Control Tower, an ATS project was forwarded to the Bids and Awards Committee-Bravo of the Civil Aviation Authority of the Philippines (CAAP-BAC Bravo) for its procurement. The project has an approved budget of Fourteen Million Pesos (Php14,000,000.00). A copy of the Certificate of Budget Allocation CBA (MOOE) 24-03-360 dated 18 March 2024 is herein attached as *Annex "A"*;

WHEREAS, the Confirmation of Mode was conducted on 06 September 2024 where the end-user requested for the Confirmation of Mode of Procurement of the project be done through Direct Contracting as stated in Section 50 of the 2016 Revised Implementing Rules and Regulations. The Confirmation of Mode was approved by the Committee. A copy of the Minutes of the Meeting is hereto attached as *Annex "B"*;

WHEREAS, the Committee issued a Request for Quotation to Unimasters Conglomeration Inc. on 16 September 2024 for the Notice for Direct Contracting. A copy of the Notice of Direct Contracting is hereto attached as *Annex "C"*;

WHEREAS, Bid Bulletin No. 01 dated 25 September 2024 was issued for the new schedule in the submission and opening of bids due to the revision of the Terms of Reference of the project. A copy of the Bid Bulletin No. 01 is hereto attached as *Annex "D"*;

WHEREAS, the Submission and Opening of bids for the project was held on 09 October 2024 at the CAAP Conference Room via in-person Meeting and Video Conference. A lone bidder submitted their bid proposal for the project, and the following results were noted. The copies of the Minutes of the Meeting and Eligibility Checklist are hereto attached as *Annexes "E" & "F", respectively*;

WHEREAS, the Bids and Awards Committee-Bravo Technical Working Group (BAC-Bravo TWG) issued its Bid Evaluation Report dated 21 October 2024. On the same date, the BAC-Bravo TWG presented its report indicating that Unimasters Conglomeration, Inc. was determined legally, technically, and financially capable to deliver the goods at the most advantageous price and contract in the amount of **Thirteen Million Nine Hundred Ninety Thousand Five Hundred Forty-Seven Pesos & 20/100 (Php13,990,547.20)**, under Sec 50.c of RA 9184. The copies of said Report and Minutes of Meeting are hereto attached as Annexes "G" & "H", respectively;

WHEREAS, Section 50 of RA 9184 *it provides that Direct Contracting or single source procurement is a method of procurement of Goods that does not require elaborate Bidding Documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale. The offer may be accepted immediately or after some negotiations. Direct contracting may be resorted to by concerned Procuring Entities under any of the following conditions:*

Sec 50.c- "Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous terms to the GoP.;

NOW THEREFORE, premises considered, the **CAAP-BAC BRAVO RESOLVES**, as it is hereby **RESOLVED** to recommend the **APPROVAL** and **AWARD** through **Direct Contracting** of the project, Provision of Maintenance Service for the Aerodrome Control Tower Simulator installed at CATC and Manila Control Tower in the total amount of **Thirteen Million Nine Hundred Ninety Thousand Five Hundred Forty-Seven Pesos & 20/100 (Php13,990,547.20)** to **Unimasters Conglomeration Inc.;**
