ECOELECTRIC SOLUTIONS, a corporation organized and existing by virtue of law and with office address at Sitio Talisay, Brgy. Candadam Baybay City, Leyte hereinafter called "the Supplier" and represented herein by MARY ANN M. FERRER in his capacity as Authorized Representative of the other part.

WHEREAS, CAAP requested quotation for certain good and ancillary services, particularly the Purchase of electrical materials for CAAP Central Office and has accepted the Quotation by the Supplier for the supply of those goods in the sum of TWO HUNDRED SIXTY-THREE THOUSAND EIGHT HUNDRED SIXTY PESOS & 23/100 ONLY (Php263,860.23) hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSTH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively as
- assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (2.1) Annual Procurement Plan CY 2024
 - (2.2) CBA (MOOE) No. 24-07-865 dated 05 July 2024
 - (2.3) Pre-Procurement (CCC) dated 26 July 2024
 - (2.4) Formal Quotation and other attachments from the Supplier
 - (2.5) Abstract of Quotation / CCC Checklist dated 07 August 2024
 - (2.6) Evaluation Report dated 06 September 2024
 - (2.7) CCC Resolution No. 2024-066 dated 09 September 2024
- 3. In consideration of the payments to be made by the Entity to the Supplier as herein mentioned, the Supplier hereby covenants with the Entity to provide the goods and services within Thirty (30) days from receipt of the Notice for Compliance and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The CAAP covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Agreement.

5. In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent (0.001) for unperformed portion for everyday of delay. Once the cumulative number of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
