 - 5.1 Current Mayor's/Business Permit;
 - Phil-GEPS Registration Number; 5.2
 - Valid PCAB License Small B Category C & D; 5.3
 - Name/credentials of proposed One (1) Construction Foreman, and One (1) Master 5.4 Electrician;
- 6. Other documentary requirements:
 - 6.1 **Omnibus Sworn Statement** (see attached format, maybe submitted together with the quotation or before issuance of Notice of Award.)
 - 6.2 Latest Income & Business Tax Returns [maybe submitted together with the quotation or before issuance of Notice of Award 1:
 - 6.2.1 Latest Income Tax Return (ITR) shall be the ITR for the preceding year, whether calendar or fiscal duly stamped received by the BIR; and

6.2.2 Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, Opening & Preliminary Examination of Bids filed through the Electronic Filing & Payment System (EFPS).

Quotations not accompanied by current Mayor's/Business Permit, Phil-GEPS Registration Number; Valid PCAB license; and Name/credentials of proposed Construction Foreman and Master Electrician shall be automatically disqualified.

Quotations will be opened in the presence of the Bidders' representatives who choose to attend at the address below. **Online submission is not allowed and late quotations shall not be accepted.**

Your prices must be quoted in Philippine Peso and must include the unit price and total price, inclusive of all taxes to be paid and other incidental cost to the delivery site if the contract is awarded. Quotations must be delivered to the Civil Aviation Authority of the Philippines, Area Center V at its physical address at the BAC/CCC Office, Ground Floor Admin Bldg., Bicol International Airport, Daraga, Albay not later than 2:00 p.m. on 18 November 2024.
