- 2. Phil-GEPS Registration Number;
- 3. Valid PCAB License Small B Category C & D;
- Name/credentials of proposed One (1) Construction Foreman, and One (1) Master Electrician;
- 5. Other documentary requirements:
 - 5.1 Omnibus Sworn Statement

5.2 Latest Income & Business Tax Returns

5.2.2 Latest Business Tax Returns shall refer to the Value Added Tax (VAT) or Percentage Tax filed and paid covering the previous six (6) months before the date of Submission, Receipt, Opening & Preliminary Examination of Bids filed through the Electronic Filing & Payment System (EFPS).

Quotations not accompanied by current Mayor's/Business Permit, Phil-GEPS Registration Number; Valid PCAB license; and Name/credentials of proposed Construction Foreman and Master Electrician shall be automatically disqualified.

- 1. Site Works
 - a. Provision of safety barricade during construction.
 - b. Removal and relocation/reinstallation of affected fixtures for the installation of drop ceiling.
- 2. Architectural Works
 - a. Installation and painting of drop ceiling above countertops (verify to plans for detail and location).
 - b. Installation of wall cladding (verify to plans for location).
 - c. Repainting of ceiling on toilets.
- 3. Electrical Works
 - a. Supply and installation of additional lighting fixtures above countertop (tap to nearest power supply).
- 4. Provision of minor tools, materials and equipments not included on itemized breakdown to be charge to OCM.


